Section I:

- 1. The Judicial Council shall retain the right to establish committees, or otherwise deliberative subordinate bodies, as deemed necessary by the voting members of the Council.
- 2. Any body established shall be subject to the authority of, and only of, the Judicial Council, unless the following conditions are met:
 - a. An agreement is made between Judicial leadership and members of the other respective ASUCR branches;
 - b. The establishment of such an inter-branch committee shall be subject to approval by a majority of the Council;
 - c. Any such committee does not violate the proper Separation of Powers through its vision, function, mission, or any other act which may be seen as overreach by any branch of ASUCR.
- 3. All committees of the Judicial Council shall be chaired by the Chief Justice, unless otherwise determined by the Chief Justice and/or the Council.
- 4. All committees shall abide by the Judicial Rules of Procedure, ASUCR Constitution, and UCR Standards of Conduct.
- 5. All committees shall be conducted in accordance with Parliamentary Procedure and shall be held in closed session wherein the Chair may invite outside members to speak.
 - a. The decision of the Chair to invite outside members is subject to an override by a majority vote of the Committee members.
- 6. At the start of each academic year, the newly elected Chief Justice will include, on the nearest possible agenda, an item regarding the composition of all committees established by this Chapter.
- 7. All committees established shall be enumerated in this Chapter of the Judicial Rules of Procedure, in accordance with the amendment procedures of this Chapter.

Section II: The Legislative Review Committee

- 1. Whereby the Judicial Council is endowed with the Constitutional authority of Judicial Review, a Judiciary Legislative Review Committee is hereby established.
- 2. The Judicial Legislative Review Committee shall:
 - a. Conduct oversight of any and all legislative actions taken by the Senatorial Legislative Review Committee and the ASUCR Senate;
 - In times of election, general or special, this committee shall include within its purview potential conflicts of interest that may arise according to Part 3, Item 5, Section B, Subsection 1 of the Elections Code;
 - c. Communicate with the Legislative Branch of ASUCR to request legislative changes to ASUCR, as deemed necessary by the Council for its proper Constitutional functioning.

Section III: The Finance Review Committee

- 1. Whereby the Judicial Council is endowed with the Constitutional authority of Judicial Review, a Judiciary Finance Review Committee is hereby established.
- 2. The Judicial Finance Review Committee shall:

- a. Conduct oversight of any and all financial actions taken by members and departments of ASUCR;
- b. Oversee the financial requests and needs of the Council for meetings, events, or other activities.

Section IV: Amendments

- 1. This chapter of the Judicial Rules and Procedures may be amended through:
 - a. A simple majority of the Judicial Council;
 - b. Amendments may only be made by members of the Judicial Branch, as defined in Chapter 1 of the Rules and Procedures;
