## **II. Committee Assignments**

### A. Legislative Review Committee

#### 1. Brief Summary:

- a) The committee has been meeting weekly on Monday mornings. We have been able to pass 10 pieces of legislation to the Senate. We decided the deadlines for legislation to be submitted, and I've been grateful to our President Pro Tempore for leading the meetings and including us all.

### B. Diversity Council

#### 1. Brief Summary:

- a) We have started community hours on Friday's with our first one being a success. We had town halls planned for this quarter, but administration has not got back to us. We are now in the rapid stages of thinking creatively for how to utilize the remainder of our budget. I have been unable to attend our biweekly meetings due to class conflict, but attend our weekly working hours to receive and give updates. Our team continues to put hard work and dedication into everything we do.

### C. Student-Parent Ad Hoc Committee

#### 1. Brief Summary:

- a) Our committee has created meetings weekly where we update one another on our work and progress in advocating for student-parents or nontraditional students. We were able to present about R'Kids to the CHASS Chairs and Directors, advocating around student-parent needs to the professors in the meeting. We had a meeting with the GSOE department to create a collaborative internship with R'Kids where GSOE students can use their 40 hours fieldwork to help tutor and engage with UCR students' dependents. Orlando and Smita began the letter writing campaign to continue spreading [SR-W21-006 Resolution Regarding Non-Traditional Student Housing Needs](#). Yvonne and Jazmin are working on a mutual aid fund for student-parents. The other student-parent members will be collaborating with me on the nontraditional event to be held. We have our meeting with Vice Chancellor Haynes coming soon to discuss the student-parent task force members.

## **III. Administrative Work**

### A. Surveys - Student Voice Committee

#### 1. Brief Summary:

- a) My senate intern, Helen Chu, and I are working on distributing two surveys. The first one has been completed and looked over by HUB Director, Brendan O'Brien, and will be distributed throughout the quarter. It surrounds the idea of lockers and further amenities students would like to see in the HUB. The second one is about student engagement and recordings or virtual meetings still being mandatory despite the transition to in person, in the coming academic year. We'd like to garner student input on what they feel should be included. Also, the Student Voice Committee has created that partnership with us to help them with their surveys.
